AGREED FINAL ORDER

WHEREAS, the parties having reached a settlement in this matter, and the Executive Branch Ethics Commission being otherwise sufficiently advised,

IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. The executed Settlement Agreement attached hereto as Exhibit A is incorporated by reference as if fully stated herein.
2. Cliff Brown shall pay the civil penalty in the total amount of one thousand five hundred dollars (\$1,500.00) in two installments. A payment of one thousand dollars (\$1000) was paid by Brown concurrently with the signing of the Settlement Agreement and has been received by the Complainant by the entry date of this Agreed Final Order. The remaining five hundred dollars (\$500) will be paid by Brown by means of a check or money order made payable to the Kentucky State Treasurer so that the total amount has been

received by the Executive Branch Ethics Commission on or before August 15, 2014.

3. If Cliff Brown fails to make payment in full in the method described in Paragraph two above, then the Executive Branch Ethics Commission may immediately file an enforcement action in Franklin Circuit Court for the unpaid balance of the civil penalty, plus twelve percent (12%) per annum from August 15, 2014, until the civil penalty is paid in full, as well as any expenses and attorney's fees associated with collecting the judgment.
4. Upon full payment of the civil penalty, this case shall be dismissed as settled.






