AGREED FINAL ORDER

WHEREAS, the parties having reached a settlement in this matter, and the Executive Branch Ethics Commission (the "Commission") being otherwise sufficiently advised,

IT IS HEREBY ORDERED AND ADJUDGED as follows:

- 1. The executed Settlement Agreement attached hereto as Exhibit A is incorporated by reference as if fully stated herein.
- 2. James Johnson agrees to pay the Commission a civil penalty in the total amount of two thousand five hundred dollars (\$2,500.00) by means of a check or money order made payable to the Kentucky State Treasurer so that the total amount has been received by the Executive Branch Ethics Commission on or before April 1, 2016.
- 3. James Johnson agrees to forfeit any tax refund that he may be entitled to receive to the Executive Branch Ethics Commission to be applied towards the civil penalty remaining referenced in paragraph 2 each year until the full civil penalty is paid.

- 4. If James Johnson fails to make payment in full in the method described in Paragraph 2 above, then the Executive Branch Ethics Commission may immediately file an enforcement action in Franklin Circuit Court for the unpaid balance of the civil penalty, plus twelve percent (12%) per annum from April 1, 2016, until the civil penalty is paid in full, as well as any expenses and attorney's fees associated with collecting the judgment.
- Upon full payment of the civil penalty, this case shall be dismissed as settled.
