ADVISORY OPINION 95-4
March 23, 1995

RE: Listing of Executive Branch Agencies

In November 1993, the Executive Branch Ethics Commission (the "Commission") issued an advisory opinion which defined executive branch agencies as those agencies which are part of the financial reporting entity of the Commonwealth of Kentucky, excluding universities, judicial and legislative entities.

In December 1994, the Legislative Research Commission ("LRC") updated its Informational Bulletin No. 171, *The Executive Branch of Kentucky State Government*. Because this bulletin provides an authoritative source of agencies in the executive branch, the Commission amends its opinion given in Advisory Opinion 93-68. Thus, all agencies which are listed as executive branch agencies in LRC's *The Executive Branch of State Government* are considered as executive branch agencies for the provisions of the Executive Branch Code of Ethics contained in KRS Chapter 11A, subject to revision by the legislature. All employees of those agencies are subject to the provisions of KRS Chapter 11A.

Please note the attached listing of agencies which are considered to be executive branch agencies. This list is intended to be all inclusive, but is subject to error or omission.
